

ALERT- UNREGISTERED OXYTOCIN ON THE GHANAIAAN MARKET

21st April 2023

During its routine market surveillance activities, the Food and Drugs Authority (FDA) has detected the presence of unregistered **OXYTOCIN INJECTION 10iu/ml** in some health facilities, including pharmacies in the country. Details of the unregistered products are as follows:

To protect public health and safety, the FDA has initiated a recall of all batches of the above products. The public is to note that because these products are not registered, their quality, safety and efficacy cannot be ascertained by the Authority. Consequently, the use of these unregistered products could be associated with life-threatening or serious risks to health.

Your Well-being, Our Priority.

In view of the above, healthcare professionals are advised to stop supplying all batches of any of these products immediately and any in stock should be quarantined or returned to the nearest FDA office for safe disposal.

ALERT- UNREGISTERED OXYTOCIN ON THE GHANAIAN MARKET

Meanwhile, the FDA is liaising with security and intelligence agencies to apprehend the importers to ensure that the market is rid of these unregistered pharmaceutical products.

The Authority is taking the necessary regulatory actions to prevent any future occurrence and will not hesitate to apply the strictest sanctions, including criminal prosecution (with a jail term up to 15 years) and the imposition of administrative fines.

The FDA assures the public of the integrity of its regulatory processes which ensure that medical and other regulated products registered for use on the Ghanaian market are safe, efficacious and of the right quality.

The public is once again reminded to check the registration status of all regulated products from the FDA website: www.fdaghana.gov.gh and on the ProPer Platform (https://bit.ly/ProPerFDA_Verify) before purchase in order to avoid any harm.
